I am pleased to be writing to you with details of our Annual General Meeting (**"AGM"**) which we are holding on 25 May 2017 at 10:00 am. The formal Notice of the AGM is set out on pages 4 to 7 of this document. The meeting will take place at Investec Bank plc, 2 Gresham Street, London, EC2V 7QP, at which the resolutions set out in brief below will be proposed.

Resolution 1, which will be proposed as an ordinary resolution, is to receive and adopt the annual report and accounts of the Company for the year ended 31 December 2016.

Resolution 2, which will be proposed as an ordinary resolution, is to approve the Director's Remuneration report for the financial year ended 31 December 2016.
